

Certification Transition Information

Candidates who hold a current ICC National Certification in selected categories (based on the International Codes) have the option of transitioning to the coordinating certification based on the California Codes, after meeting certain criteria. These generally include an online exam, seminar, and/or training, as well as submittal of a transition application and fee.

The following options are available for achieving transition:

1. Completion of the relevant transition exam

2007 California Codes transition exams are offered via the Online Certification Renewal Update program on the Code Council website at www.iccsafe.org/renewals. Transition exams are based *primarily* on the California amendments to the model codes. All transition exams are open book with no specific time limit to complete each exam; however, there is a 99-day limit for the Online Renewal Update Program. This limit begins on the date that you register for this program. All registration, fee payment, and exam administration is completed online. Once you have completed the online exam(s), a separate application and fee are required for the transition(s). The applications are included in this Appendix.

2. Completion of training based on the 2007 California code(s) referenced by the specific exam

A. CALBO seminars:

S1 seminar: *California Building Code*

S2 seminars: *California Electrical Code; California Mechanical Code; or California Plumbing Code*

S3 seminar: *Accessibility and Usability or ADA Accessibility*
