101.2.1 (New)

Proponent: Rebecca Baker, Jefferson County, CO, Chair, ICC Ad Hoc Committee on the Administrative Provisions in the I-Codes (AHC-Admin)

Add new text as follows:

101.2.1 Appendices. Provisions in the appendices shall not apply unless specifically adopted.

Reason: Consistency and coordination among the I-Codes are cornerstones of the ICC Code Development Process. This holds true for not only the technical code provisions but also for the administrative code provisions as contained in Chapter 1 of all the I-Codes.

In response to concerns raised by the ICC membership since publication of the first editions of the I-Codes, the ICC Board established, for the 2006/2007 cycle, and extended, for the 2007/2008 cycle, the ICC Ad Hoc Committee on the Administrative Provisions in the I-Codes (AHC-Admin) to review Chapter 1 administrative provisions in the International Codes family and improve the correlation among the I-Codes through the code development process.

The AHC-Admin is submitting a series of code change proposals designed to provide consistent and correlated administrative provisions among the I-Codes. The intent of this correlation effort is not necessarily to have absolutely identical text in each of the I-Codes but, rather, text that has the same intent in accomplishing the administrative tasks among the I-Codes.

The purpose of this proposed change is to provide correlation with Section 101.2.1 of the *International Building Code*, *International Fire Code* and *International Mechanical Code*, Section 102.1 of the *International Plumbing Code*, Section 101.3 of the *International Fuel Gas Code*, Section R102.5 of the *International Residential Code*, Section 101.7 of the *International Existing Building Code* and the change that was approved in the 2006/2007 cycle which added new Section 101.2 to the *International Wildland-Urban Interface Code* (see *Supplement to the International Codes, 2007*).

In accordance with established I-Code style, the provisions contained in code appendices are not considered part of the code and are, therefore, not enforceable unless they are specifically included in the ordinance or other adopting law or regulation of the jurisdiction. This new section will make it clear as to the status of the two code appendices.

This proposal will also correct an error in the modification made to code change PSD1-06/07. The IPC Development Committee modified the code change by deleting proposed new section 101.2.1 on the basis that the subject matter was already covered in Section 101.2. However, code change PSD1-06/07 also deleted the text in Section 101.2 that dealt with the status of the appendices, so the net result is that both the old text and the proposed new text were both deleted. This proposal places the text in a separate section, just as it is in the other I-Codes as noted above.

Cost Impact: The code change proposal will not increase the cost of construction.

PSD2-07/08

302.7 (New)

Proponent: Sidney L. Cavanaugh, Cavanaugh Consulting, representing In-Sink-Erator

Add new text as follows:

302.7 Food waste disposals. Where a food waste disposal connects to a private sewage disposal system, the system shall be designed to accommodate the solids loading from the disposal unit.

Reason: This new section recognizes that garbage disposals can be used on septic systems when properly accounted for in the design of the septic system.

Cost Impact: The code change proposal will increase the cost of construction.
