### Group A Code Change Proposals Due by January 12!

Work is well underway on ICC's 2015/2016/2017 Code Development Cycle that begins with the Group A International Codes. This will be the first full cycle that utilizes cdpACCESS, ICC's new cloud-based system that allows for online collaboration, code change and public comment submittals, submission of floor modifications, and online voting. A change to section 3.3.5.6 of [Code Council Policy 28](#) also is new to this cycle that addresses cost impacts of code change proposals. ### **Newly Available U.S. Fire Administration Reports Address Fire-Related Problems**

Despite code requirements for smoke alarms, the report finds smoke alarms were not present in 22 percent of the larger fires in occupied residential buildings. Primarily based on data collected through USFA's National Fire Incident Reporting System (NFIRS), the reports briefly address the nature and relevance of the specific fire or fire-related problems, highlight important findings, and suggest other resources to consider for further information.
