

RESULTS OF PHASE ONE OF THE ONLINE 2015 GROUP A PUBLIC COMMENT HEARING VOTE (Update 2/5/16)

2/5/16 Update: Prior to the OGCV going live on February 8th, an audit of the Online PCH 1 Vote tallies identified a problem with the reported results. With the exception of E12 – 15 (see Note 9 below), the vote tallies did not impact the PCH 1 resulting actions or the actions placed on the OGCV. This 2/5/16 update shows the corrected vote tallies which were incorporated into the OGCV prior to the OGCV going live on February 8th.

On November 3, 2015, ICC announced the procedures to address the 2015 Group A Public Comment Hearing voting problems with the electronic voting devices. The two-step electronic voting process is intended to closely mirror the process used to conduct the in-person Public Comment Hearing, resulting in accurate and transparent Public Comment Hearing results to be used to conduct the Online Governmental Consensus Vote (OGCV). Eligible voting members for the two step process are limited to those who were issued an electronic voting device during the Public Comment Hearing in Long Beach, CA. cdpACCESS transferred the voting results for those who voted in Long Beach. Eligible voters were not permitted to change their vote. However, if a vote was either not recorded or the voter did not vote, the voter was permitted to vote.

The two-step electronic process only applies to those codes impacted by the electronic voting devices. This includes all codes on the 2015 Group A Public Comment Hearing agenda except: IBC – Fire Safety code changes FS 64 through FS 179; all IBC - General code changes; and S2 -15 which was heard by the IBC – Fire Safety committee.

The first step in the electronic voting process (PCH 1) opened on January 19th and closed on January 25th. The process mirrored the normal in-person Public Comment Hearing with a motion to sustain the action from the 2015 Group A Committee Action Hearing (CAH) in accordance with Section 7.5.8.5 of CP 28 (see link below). Section 7.5.8.6 of CP 28 allows a subsequent motion to be considered where the CAH action is either Approval as Submitted or Approval as Modified (e.g. E5-15 Part II: PCH 1 motion is AMPC 1). The results have been audited by ICC's third party auditor and are reported on the following pages.

PCH 1 notes:

1. PCH 1 Motion: This is the motion voted on in PCH 1. See discussion above.

2. In-Person Long Beach Vote: This is the vote that was recorded at the Long Beach Public Comment Hearing and reported on the PCH 1 ballot. Where the Long Beach vote is noted as 0 – 0, this means that there was not a recorded vote for this motion and the Long Beach action was determined by a visual observation by the Moderator (e.g. E27-1: PCH 1 motion for AMPC #1 and #2)
3. PCH 1 Vote Total: The vote total listed in the table is the combined total of the “In-Person Long Beach Vote” which was reported on the PCH 1 ballot and the “Online PCH 1 Vote”. This also includes the resulting voting percentages.
4. PCH Action to OGCV: Whenever the PCH 1 vote determined the Public Comment Hearing action for the code change, it is listed in this column. This is the action that will be reported as the official 2015 Group A Public Comment Hearing action and will be placed on the OGCV. See Example 1 below. See also note 7.
5. PCH 2 Motion: Entries in this column indicate that the code change will be placed on the PCH 2 ballot with the motion indicated based on the results from PCH 1. See Example 2 below.
6. The required majorities for successful Public Comment Hearing action are listed in Section 7.6 of CP 28. It is important to note that in some cases a simple majority may have been achieved but the requisite majority per CP 28 is 2/3. (e.g. E27-15; AMPC #1 vote was 26 – 24; motion failed).
7. Where the “PCH Action to OGCV” indicates Note 7, this means that the PCH 1 vote did not achieve the requisite majority to pass, however, the code change will not be considered on PCH 2 since the allowable ballot actions for the OGCV are not affected. For example, the PCH 1 motion on E5 Part II was for AMPC #1. This motion failed. Due to the lack of submitted comments for AS, the OGCV ballot options are the committee action of AM and D in accordance with Section 8.1 of CP 28. Similarly, the PCH 1 motions on E27 were for AMPC #1 and #2. Both of these motions failed. The OGCV ballot options are limited to the committee action of AS and D in accordance with Section 8.1.
8. The shaded “PCH Action to OGCV” for code changes FS37, FG9, FG 34, P41, P55 Part I and SP32 is a correction from the original posting.
9. The shaded “PCH Action to OGCV” for code change E12 – 15 is a correction from the original posting. An audit of the vote tallies was performed prior to the OGCV going live on February 8th. The audit uncovered that the PCH 1 motion for disapproval of E12-15 failed by a vote of 65 – 68. Per procedures, PCH 2 should have included a motion for AMPC 1 in accordance with CP 28. Since the error was identified after the PCH 2 process was completed, AMPC 1 was placed directly on the OGCV for the memberships vote.

The second step in the process (PCH 2) is scheduled to start on January 29th and be open through February 1st. This process will mirror PCH 1 with the motion considered based on the results from PCH 1. Here are two examples:

Example 1: The PCH 1 result for E2 – 15 was 118 – 17 in support of the motion for Disapproval. The motion for Disapproval passed. As such, and in accordance with CP 28, the Public Comment Hearing action for this code change is Disapproval and the code change will not be considered in PCH 2. This is noted in the table under “PCH Action to OGCV”. The next step for E2 will be to place the code change on the OGCV with the ballot options being Disapproval (the Public Comment Hearing action) and Approval as Submitted, in accordance with Section 8.1 of CP 28.

Example 2: The PCH 1 result for E32 – 15 was 100 – 34 in opposition to the motion for Disapproval. The motion for Disapproval failed. In accordance with Section 7.5.8.8 of CP 28, a motion for As Modified by Public Comment is order. As such, E32 will be placed on the PCH 2 ballot with a motion for AMPC 1.

Following the audit of the results for PCH 2, the results will be posted. Along with the PCH 2 results, we will also post a comprehensive list of the results of all the code changes for the 2015 Group A Public Comment Hearing. These will be the results that determine the ballot options to be placed on the OGCV.

The OGCV is scheduled for February 8 – 21. Unlike PCH 1 and PCH 2 where the eligible voters were limited to those at the Long Beach Public Comment Hearing, all Governmental Member Voting Representatives and Honorary Members who were validated for the 2015 Group A cycle are eligible to vote.
