- 1.0 **Purpose of Council Policy:** This policy establishes the different categories for ICC membership and outlines the benefits afforded to each category.
- 2.0 **Objectives:** Through International Code Council Membership, safety professionals from around the world work together in partnership with their peers in the profession. ICC’s global mission and vision are accomplished only through the engagement and support of its Members.
- 3.0 **ICC Membership Categories:**
 - 3.1 **Public Sector Member categories:** In compliance with Article II – Membership and Article X – Code Development Process of the ICC Bylaws, Public Sector Members are those whose voting privileges extend to the Annual Business Meeting as described in CP#19, and to the Code Development Process, including Public Comment votes, as described in CP#28. These categories include:
 - 3.1.1 **Governmental Members:** A governmental unit, department or agency engaged in the administration, formulation, implementation or enforcement of laws, ordinances, rules or regulations relating to the public health, safety and welfare.
 - 3.1.1.1 **Governmental Member Voting Representatives:** Each Governmental Member shall exercise its votes through its designated Governmental Member Voting Representative.

- 3.2 Private Sector Membership categories:** In compliance with Article II – Membership and Article X – Code Development Process of the ICC Bylaws, Private Sector Members include “users” and “producers” as defined in ICC’s ANSI procedures.
- 3.3 Corporate Member** - An organization such as an association, society, testing laboratory, institute, company, manufacturer or corporation, interested in the purposes and objectives of the Council. Any government organization not meeting the criteria of a Governmental Member as described in Article II of the ICC Bylaws may also join as a Corporate Member.
- 3.4 Individual Member** - An individual in one of the following categories:
- 3.4.1 Professional Member**- An individual who is interested in the purposes and objectives of the Council and wishes to partake in top-tier member benefits.
- 3.4.2 Student Member** - Any individual enrolled in high school, college or university classes or a similar course of study.
- 3.4.3 Participating Member** – An individual who supports and participates in Council events and activities and wishes to purchase basic member benefits.
