**1.0 Welcome and introductions - Chair Baldassarra**

**1.1 Call to order; introductions; welcoming remarks**

Carl called the meeting to order at approximately 9:00 am on December 8th.

Self introductions were made. See Appendix A for a list of attendees.

**3.1 Approval of March 26 - 27, 2014 Minutes (posted under CTC Meeting Minutes)**

**3.2 CTC Sun Setting**

**3.2.1 Remaining Areas of Study (posted under CTC Sun Set notice)**

Staff explained the Board's decision to sun set the CTC by the end of the 2016 Group B cycle. All current CTC committee member terms have been extended to 12/31/16. Two CTC Areas of Study remain with the CTC: Care Facilities and Elevator Lobbies/WTC Recommendations (Elevators). Information concerning the sun setting is posted on the CTC website.

**3.2.2 Update Study Group matrix (posted under CTC Misc. Documents)**

CTC reviewed the current matrix and updated it to make sure that each of the CTC members are involved in one or both of the two remaining areas of study. The updated matrix will be posted.

**3.3 2014 Cycle – cdpACCESS debrief (posted as “Summary of Final Action Group C Code Changes” at website link below)**

Staff noted that about 200 unique voters voted online on the Online Governmental Consensus Vote (OGCV) and that the results are posted. The results show both the vote at the Public Comment Hearing and the OGCV.

**4.0 Care Facilities (posted under CTC Upcoming Meeting)**

**Agenda item 1 of 2**

Significant issues:

- Questions concerning Group A vs Group B arose. If the issue is strictly a correlative cross reference in a Group B code, the proposal can go to Group A with the correlative cross reference in the Group B code identified in the proposal.
- Proposal 7: Need to clarify the application of sprinkler protection for Groups R-3 and R-4.
- Proposal 25: In process. Both CTC and FCAC looking at suite style designs in dorms and assisted living facilities. To be discussed with FCAC under item 7.1

**Agenda item 2 of 2:**

Significant issues:

- Proposal 3: CTC has concerns with the proposed language dealing with distance of travel to smoke barriers.
- Proposal 23: Change terminology to “care recipients” to be consistent with other sections of the code. How you determine if someone was moved in beds or not (application of 2.1 or 2.2)? Does this correlate with NFPA 101?

**5.0 Elevator Lobbies/NIST WTC elevator issues (posted under CTC Upcoming Meeting)**

**Agenda item 1 of 5:**

Significant issues: Send back to SG. The wording needs clarification

**Agenda item 2 of 5:**

Significant issues: The proposed text is too lengthy. Need to split up into two conditions: over 420’ and 3 stories, non sprinklered. CTC is waiting for feedback on fire modelling being conducted by students at the University of Texas at Austin. The concerns voiced to date are locale specific based on what was previously in the respective model codes. This will likely require a follow up public comment based on modelling results.

**Agenda item 3 of 5:**

**Agenda item 4 of 5:**

This agenda item was updated based on a Study Group call on 12/4/14.

Significant issues:

- Assumptions to be used by University of Texas at Austin modelling utilizing a Fire Dynamic Simulator developed by NIST.
- Tenability criteria. Fast response sprinklers address tenability on the fire floor, what about the other floors? How much smoke is acceptable?
- Tenability is not the only issue. What are the other performance criteria?
- CTC reviewed the table and provided input.

Limited discussion on the modelling parameters (building size).

**7.1 Joint discussion on agenda item 6.2**

**FCAC:**

The CTC members met with the FCAC in their meeting room, along with interested parties, to discuss the items that were being transferred from the CTC to the FCAC in accordance with the ICC Board’s direction.

Drafts of 7 code changes were presented and discussed, identified by the following CTC Areas of Study:

- Unenclosed Exits – 2 proposals
- IBC Coordination with ADAAG – 3 proposals
- Labelling of fire rated glazing – 2 proposals

In addition, there was considerable discussion on a proposed draft of a proposal that crosses the respective scopes of the CTC, FCAC and BCAC. The issue is one of suite layouts in Groups I-1 and R-1. Both the FCAC and CTC were investigating suite style designs in dormitories and assisted living facilities. This comprehensive draft covered many aspects of the IBC including: definitions; occupancy classifications; separations; fire protection features; and accessibility. Given the time constraints, it was noted that conclusions would not be reached during the meeting so follow-up telephone calls would be needed.

**BCAC:**

Following the meeting with the FCAC, the CTC members went to the BCAC meeting room, along with interested parties, to discuss the items that were being transferred from the CTC to the BCAC in accordance with the ICC Board’s direction. Drafts of 38 code changes were presented and discussed, identified by the following CTC Areas of Study:

- Child Window Safety – 2 proposals
- Climbable Guards – 1 proposal
- Unenclosed Exits – 6 proposals
- IBC Coordination with ADAAG – 27 proposals
- Relocatable Modular Buildings – 2 proposals
