# **FEMA Offering Two New Training Opportunities**

FEMA has two open training courses available in Emmitsburg, MD through the Emergency Management Institute. The first 4-day course will run from July 28-31 and will cover retrofitting flood-prone residential buildings. The second 4-day course will run from August 18-21 and will train participants on FEMA's Coastal Construction Manual, created for planning, designing, and constructing residential structures in various coastal environments. ## **New Advanced Permit Certification Coming Soon**

The Board for International Professional Standards (BIPS) has reviewed the survey results for an advanced level of Permit Technician, and has approved a new category – **Certified Permit Specialist**. To become a Certified Permit Specialist, applicants will first be required to pass the Permit Technician Exam and second, pass the soon-to-be-developed "Administrative" exam. This exam will be used for the certification categories where the title is "Specialist", and will be a prerequisite to obtaining certification as a Plumbing, Mechanical, or Fire Code Specialist.
