

FINAL PUBLIC COMMENT HEARING RESULTS ON THE 2015 PROPOSED CHANGES TO THE INTERNATIONAL CODES – GROUP A (UPDATED)

THIS DOCUMENT IS THE FINAL PUBLIC COMMENT HEARING RESULTS FOR THE 2015 GROUP A CYCLE AND SUPERCEDES THE PUBLIC COMMENT HEARING RESULTS PREVIOUSLY POSTED FOLLOWING THE 2015 PUBLIC COMMENT HEARING IN LONG BEACH, CA.

On November 3, 2015, ICC announced the procedures to address the 2015 Group A Public Comment Hearing voting problems with the electronic voting devices. The two-step electronic voting process closely mirrored the process used to conduct the in-person Public Comment Hearing, resulting in accurate and transparent Public Comment Hearing results to be used to conduct the Online Governmental Consensus Vote (OGCV). Eligible voting members for the two step process were limited to those who were issued an electronic voting device during the Public Comment Hearing in Long Beach, CA. cdpACCESS transferred the voting results for those who voted in Long Beach. Eligible voters were not permitted to change their vote. However, if a vote was either not recorded or the voter did not vote, the voter was permitted to vote.

The two-step electronic process only applied to those codes impacted by the electronic voting devices. This included all codes on the 2015 Group A Public Comment Hearing agenda except: IBC – Fire Safety code changes FS 64 through FS 179; all IBC - General code changes; and S2 -15 which was heard by the IBC – Fire Safety committee. The votes taken on these code changes were determined by a visual determination by the Moderator.

The first step in the electronic voting process (PCH 1) opened on January 19th and closed on January 25th. The second step in the electronic voting process (PCH 2) opened on January 29th and closed on February 1st. The results of these two steps have been previously [posted](#).

The results from the two-step electronic voting process coupled with the Public Comment Hearing results from Long Beach for those code changes whose action was determined by the Moderator is the basis for these Final Public Comment Hearing results.

These results also include the voting options for the Online Governmental Consensus Vote (OGCV) in accordance with Section 8.1 of CP 28. The OGCV is scheduled to open on February 8th and close on February 21st. All Governmental Member Voting Representatives who were validated for the 2015 Group A cycle and Honorary Members are eligible to vote on the OGCV.
