Solar thermal collectors using a fluid for heat transfer—Types: Glazed, unglazed, concentrating, tubular, transpired, PVTs – Fluids: Air, Glycol, Water, etc.

ICC 900/SRCC 300

Solar energy systems used for heating, cooling, dehumidification—Types: Residential, commercial – Subassemblies/Components: Pump stations, unfired tanks (pressurized & unpressurized)

ICC 902/APSP 902/SRCC 400

Solar water heating systems used with swimming and wading pools and spas—Types: Residential, commercial – Approved in 2017.
