William Clayton is a consultant with Colorado Code Consulting since 2015. Jim Olk is Building Official for the City of Garland, Texas. Jim has worked for municipal governments for over 35 years and serves on several local, regional, and national Boards and Councils. Jim heads up the Disaster Response Team for the Building Officials Association of Texas and was the Lead Responder for damage assessment for 8 disasters including the fertilizer plant explosion in West, tornado in Cleburne, the flood and tornado in Garland, and Hurricane Harvey along the Texas Gulf Coast.

Kevin Scott is President of KH Scott & Associates, LLC and serves on the Board of Directors for the International Code Council. During his 30-year career with the Kern County California Fire Department he worked up through the ranks in his career and served the Fire Department in several different capacities, retiring at the position of Deputy Chief.
