2022 International Code Council Annual Conference, Expo and Hearings to Kick Off in Louisville

Building safety professionals will discuss the 2024 I-Codes and attend networking and learning opportunities

Washington, D.C. – The International Code Council will be hosting its Annual Conference, Expo and Public Comment Hearings at the Kentucky International Convention Center in Louisville, KY, from September 11 - 18, 2022. The event will welcome building safety professionals from around the world and feature keynote speeches, networking opportunities, educational sessions and the return of the Code Council's Expo.

"As our 2022 conference begins, we welcome the opportunity to bring together professionals from all parts of the building safety industry to work towards our common goal of improving safety, sustainability and affordability through building codes and standards," said Code Council Board of Directors President Cindy Davis, CBO. Award-winning speaker and entertainer Michael C. Anthony will headline the Leadership Luncheon on Monday, September 12. From September 14 - 18, the Public Comment Hearings provide attendees with an opportunity to directly impact the 2024 International Codes (I-Codes), the most widely-used and adopted set of building safety codes in the world.
