

Membership Councils Annual Report 2025





## Membership Council Steering Committee

The Membership Council Steering Committee (MCSC) was created by Council Policy 09-04 in December 2023. MCSC is composed of the chairs and vice chairs of the seven membership councils (MCs) or their designees. MCSC helps to coordinate membership council activities, minimize duplication of effort, ensure that the membership councils are serving the best interests of ICC members, and facilitate communication between the membership councils and the ICC Board of Directors.

Some of MCSC's major accomplishments in 2025 include:

#### **Annual Membership Council Report to the Board**

The MCSC worked to ensure coordination between councils on similar tasks, the MCSC required each Membership Council to report on their 2025 and define at least three goals for 2026 for which it will be held accountable by the MCSC. The success of the 2025 goals as well as an explaination of the 2026 are further defined in the following sections for the respective councils.

#### **Cross Membership Council Coordination**

This year, in addition to the membership welcome package, there were three initatives that involved coordination across multiple membership councils. ELMC lead a survey on code development process enagement with support from BMC and SMC. SMC created and promoted the Building Safety Month social media campaign with support from ELMC, FSMC, GMC, and BMC. Finally, FSMC and BMC hosted a joint meeting with educational offers, which resulted in over 100 atteendees. In addition, numerous 2026 MC goals reference coordinating with and support other MCs. MSMC has been a success in bringing together MCs to help foster better coordination and member support.

#### **Membership Welcome Package**

Various MCs have attempted to create resources for encouraging member engagement with MCs or to welcome new members. This year, MCSC was able to complete a draft of two documents for this purpose by partnering across multiple MCs. The first document is a one-pager that highlights the benefits of MCs and encourages ICC members to join on the Member Community Platform. The second document is another one-pager that provides new MC members with information about how to become more involved now that they joined an MC. The hope is to publish these documents in early 2026.

#### MCSC's 2026 Goals

**Annual Membership Council Report.** Coordinate with all the MCs to ensure each one has an opportunity to highlight their successes and their future goals, including quantifiable metrics if relevant.

**Publish the Membership Council Welcome Package.** Two separate drafts of one-pagers to promote engagements with MCs have been completed. The goal for 2026 is to publish these documents with the support of ICC staff.

#### Creation of a MC Guiding Document to support CP#9-04.

The MCSC learned a great deal in the first two years of its existence. In the spirit of continual improvement, MCSC will produce a document that provides guidance and support for both CP#9-04 and the individual MC's rules, procedures, and objectives. This may also include suggestions for changes to CP#9-04 based on lessons learned.





## Building Membership Council

The Building Membership Council (BMC) strives to enhance professionalism and advocate for concerns and issues that are of particular interest to building officials, to assist ICC in increasing the participation in the code development process by building officials, and to advise ICC on programs and policies, legislative matters, code adoption issues, and other matters identified by the governing committee. BMC's governing committee has 13 members representing 12 states.

BMC held eight meetings, with an average of 40 attendees per meeting. Meeting attendance increased throughout the year with improvements in the Member Community Platform and increased membership numbers. Among the 2025 meetings was a very successful joint meeting with FSMC that attracted more than 100 attendees. In 2025, BMC worked through three subcomittees: Raising the Profile, Education, and Code Development Participation. The subcommittees emphasized collaboration with other membership councils to achieve common goals.

Some of BMC's major achievements in 2025 include:

## 1. Hosted engaging and relevant topical presentations

BMC provided multiple presentations throughout 2025 on current topics of interest to BMC during the regular meetings. BMC also used the membership council meetings to highlighted other training and engagement opportunities hosted by ICC throughout the year. The highlight this year was a joint meeting between FSMC and BMC that included a training on A2L Refrigerants that had over 100 attendees.

#### 2. Developed a new training program for the ABM

BMC provided a 30-minute Expo Talk at the ICC Annual Conference, "Getting Plugged In: Pathways to Engagement and Opportunities within ICC," as well as "How To Build A Successful Leadership Team" at the 2025 Chapter Leadership Academy. While BMC was able to achieve this goal, it required considerably more effort than past years to coordinate with ICC training staff and BMC was disappointed not to be able to present at a full session as was done in the past. BMC will not pursue this goal in 2026 due to the experience in 2025.

## 3. Partnered with ELMC on the Vote for Your Codes campaign

BMC provided support to ELMC on their Vote for Your Codes campaign this year through the development, promotion, and publication of a survey on code development. The survey had 500 respondents, half of which were governmental voting members. The results can be found in Appendix A.

#### BMC's 2026 Goals

**Provide Training.** BMC will provide four trainings throughout the year. Given the challenges with obtaining a "spot" at the ABM, BMC will include these educational sessions as part of the regular BMC meetings.

**Increase Member Engagement.** BMC has 242 members according to the Member Community Platform. The goal is to increase membership by 10% (25 new members) through social media and other outreach efforts.

**Support other MCs** BMC experienced significant success through partnerships with FSMC, ELMC, and SMC in 2024. To continue this success, BMC will partner with other MCs on a minimum of three initiatives. Suggested initiatives are Building Safety Month (SMC), Vote for Your Codes (ELMC), joint meeting with FSMC, and/or Best Practices (MJMC).





## Emerging Leaders Membership Council

The Emerging Leaders Membership Council (ELMC) accelerates young professionals on a path to future leadership within the profession. ELMC connects current leaders with new talent and perspectives to challenge conventions and redefine success. For those involved with ELMC, it is a vehicle to grow professionally and create connections that will last a lifetime. ELMC is open to all ICC members but is focused specifically on members age 35 and under and members who have been in a codeenforcement-related position for less than 10 years.

The ELMC is led by its governing committee, which has eleven members. In 2025, ELMC focused on building the professional knowledge and networks of ELMC members.

Some of EMC's major accomplishments in 2025 include:

## 1. Created materials to improve member understanding of cdpACCESS

Through the "Vote For Your Codes" Initiative, which is led by ELMC but is comprised of members from the SMC and BMC, ELMC created content to help the ICC membership better understand how to register to vote, validate voters and participate in the code development process. A survey of 500 ICC members was completed over the spring and summer of 2025 and summary of survey results is available in the Member Community a well as at in Appendix A of the report.

## 2. Hosted engaging educational presentations for ELMC members

ELMC coordinated educational presentations on programs provided by the Code Council that are helpful to code officials. Presentations were included at every regularly scheduled ELMC meeting. Topics included: Using the ICC Member Community (January), Using Monday.com (March), I Built This (April), ICC Voter Validation and Registration (June).

#### 3. Expanded social media engagement

ELMC increased our social media presence and outreach and also increased followers, shares, reposts, and views. In 2025, ELMC averaged 2.5 posts per month. Posts related to Building Safety Month received over 8,000 views in May. ELMC's member community page has had over 3,900 visitors so far. On Facebook, ELMC has over 500 followers with a high level of engagagement from followers and non-followers.

#### ELMC's 2026 Goals

Code Development Participation. Utilize Vote for Your Codes data collection and continue to help members learn about and understand the process while encouraging them to get more involved in code development. Based on the V4YC survey results, reach 10% more awareness of the code development process and 5% more participation in cdpACCESS.

#### Increase outreach and increase new membership.

Set an in-council challenge for each member of the governing committee to bring a new member to two separate meetings within the 2026 calendar year. Target: 24 first-time attendees

**Social Media Engagement.** "Get to know the Leaders" will be a social media post/digital flyer that will recognize a member of the ELMC and give a very brief background of who they are, where they are from, what they do and why they are here. Target: minimum six posts/digital flyers per year.





## Fire Service Membership Council

The Fire Service Membership Council (FSMC) is a forum for concerns and issues that are of particular interest to the fire service. FSMC assists ICC in increasing participation of fire service members in the code development process. FSMC also advises ICC on programs and policies, legislative matters, code adoption issues and such other matters identified by its governing committee.

FSMC's governing committee has a unique stucture: 12 of the 18 governing committee members are appointed per the FSMC MOU; the remaining six seats are appointed by the ICC Board of Directors. FSMC held 11 general meetings over the last year with an average of over 50 attendees per meeting. One of these meetings was a very successful joint meeting with BMC that attracted more than 100 attendees.

FSMC has four work groups: Emerging Issues and Trends, Public Awareness, Training and Education, and Member Engagement.

Some of FSMC's major achievements in 2025 include:

- 1. Promoted training and certification opportunities for the fire service
- 2. Organized presentations on emerging issues and topics
- 3. Emerging Issues and Public Awareness Working Groups collaborated to develop and disseminate training materials on identified issues

FSMC chose to select three goals that all worked together to support the needs of Fire Service Professionals across the country. Because these three goals were all intertwined, FSMC had a very successful year and exceeded expections for all three goals.

FSMC provided seven different educational presentations as part of their regular meetings. Presentation topics included fire loss and mitigiation evaluation scores

(FLAMES), sinlge stair, battery and energy storage systesms, CO poisioning, and hyperbaric facilities. These topics were all emerging issues throughout the year. The trainings generated both awareness and engagement, and often included training materials or resources.

FSMC continues to work on the goal of bringing topical issues and training resources to their members. They have begun to develop courses that can be delivered with the assistance of new ICC staff.

FMSC continues to work with partner organizations such as International Fire Chiefs, National Association of State Fire Marshals, Congressional Fire Service Institutes by representing ICC and inviting BOD leaders to several events.

#### FSMC's 2026 Goals

#### FSMC Webpage with Emerging Trends and Issues.

FSMC will continue working with ICC on the FSMC Webpage and continue working on our emerging issue and trends tracking and document management process. FMSC is moving forward with making the Emerging Trends and Issues worksheet available for all ICC members to use. This will hopefully be located on the Membership engagement platform which should provide web access.

**Written Articles.** FSMC will provide written articles from the prioritized subject list at least once a month to be published using the appropriate ICC-provided template. This will be promoted through social media messaging with platforms such as TikTok, Facebook, and YouTube as approved by ICC staff.

**Education Presentations.** The Member Engagement Committee Workgroup members will lead and assist in the coordination of educational presentations that deliver information which is related to the FSMC and will assist with increasing attendance and participation at the monthly FSMC Membership Council Meetings.





## ICC Global Membership Council

The Global Membership Council (GMC) connects building safety professionals from outside the United States with US-based professionals who have an interest in advancing the cause of building safety internationally. GMC encourages participation by professionals interested in networking with others from around the world and engaging in dialogue about building safety challenges that are relevant regardless of what codes or regulations are enforced. GMC also welcomes those who are interested in learning more about how ICC's advanced model codes and capacity building services can be used by countries around the world to improve building safety.

Seven countries are represented by the twelve members of the GMC's governing. In 2025, GMC had a productive year, with average meeting attendance of 18.

Some of GMC's major achievements in 2025 include:

## Convened engaging webinars on topics of global concern

In 2025, GMC aimed to present at least four webinars. In March GMC presented Resiliency: Consideration Beyond Code Requirements with Sahim Rashid-Sumar of the National Ready Mixed Concrete Association. In July, GMC presented Building Inclusion: What Needs to Change for a Safer Built Environment with Marsha Ramproop. Further webinars are under development.

#### Incorporated guest speakers into regular meetings

GMC's goal was to incorporate guest speakers into all general meetings. In 2025, all general meetings except one included a presenter, and work is in progress to secure presenters for future general meetings. Presenters have included Dr. Kimberly Martin, who spoke on advancing sustainability in the geotechnical industry, and Neil Savery with a recap of International Building Safety Day.

#### **Growing GMC's membership**

GMC's efforts to grow membership and participation remains a work in progress. Staggering meeting times to accomodate a global audience remain under consideration. GMC is also developing a succict statement of the "value proposition" of GMC participation.

#### GMC's 2026 Goals

**Continue to present engaging webinars.** In 2026, GMC intends to continue its successful webinar series. GMC intends to hold at least four webinars.

Continue to incorporate presentations in general meetings. GMC also intends to continue to incorporate guest speaker presentations into its general meetings. The goal for 2026 is to have a guest presentation as part of every general meeting.

Continue to grow GMC membership. This goal will be monitored both through the Member Community Platform as well as other means of engagement. Because many global members are not necessarily ICC members, GMC will work with staff about how to reach and engage members outside the platform or provide a means for those members of relevant partners and stakeholders to access the platform.





### Major Jurisdiction Council

The Major Jurisdiction Council (MJC) is the premiere forum for federal, state, and major jurisdiction leaders in code development and code enforcement. MJC demonstrates the benefits of code officials working together for common purposes.

In 2025, MJC's productive year included eight meetings held with an average meeting attendance exceeding 30.

Some of MJC's major accomplishments in 2025 include:

## Organized engaging and interactive presentations on hot topics

In 2025, MJC set out to present relevant educational programs that faciliate learning and collaboration for all ICC members. The MJC delivered four educational presentations to its members, including: Archistar eCheck techology (March), and AI for building officials (August).

## Provided a forum for major jurisdictions to explore emerging issues

MJC aims to be a resource for major juisdiction members to explore emerging issues. In 2025, MJC held bimonthly meetings with open forums for participants to discuss special topics. Most notably, MJC discussed the Los Angeles, CA, wildfires, FEMA affordable housing, access to public restrooms, virtual inspections, townhome provisions in the IRC, 3rd party bills in the legislature, temporary housing for homelessness, and single stair access for apartments. Committee members also attended regional meetings throughout the year and continued to push engagement through the ICC Member Community.

## Recruited contributions to the best practices database

MJC continues to work with staff to update the ICC Best Practices webpage with current and relevant content.
MJC is looking to build additional partnerships for future versions of the Best Practices manual.

#### MJC's 2026 Goals

**Educational Presentations.** Continue to provide engaging and relevant educational presentations and forums for discussion throughout the year. Target: Four presentations.

**Expand Outreach and Engagement.** Develop and create social media presence through sites such as Facebook and LinkedIn. Increase MJC membership on the Membership Community Platform by 10%. In addition, clarify that all ICC members can attend any trainings as well as access resources created by MJC.

**Expand Best Practices.** Goal to review and update a minimum of two past best practice and create one new best practice.





## PMG Membership Council

The PMG Membership Council (PMGMC) serves the needs of PMG officials and industry professionals. The purpose of PMGMC is to advocate for concerns and issues that are of particular interest to plumbing, mechanical, fuel gas, pool and spa professionals. PMGMC continues its mission to support alignment, consistency, and advancement across all PMG disciplines through collaboration and advocacy. In recent efforts, the Council has placed significant focus on strengthening and integrating swimming pool and spa code standards across partner organizations, jurisdictions, and ICC committees.

Some of PMGMC's major achievements in 2025 include:

#### **Published four new CodeNotes on relevant topics**

A signature initiative PMGMC is the CodeNotes series—a collection of concise, code-referenced documents aimed at enhancing understanding and effective field application of model code provisions. Targeted toward inspectors, plan reviewers, contractors, designers, and other industry professionals, CodeNotes serve as accessible resources to clarify complex code concepts through diagrams, explanatory notes, and real-world context. The CodeNotes library currently includes more than 30 technical bulletins. PMGMC will release four new CodeNotes by the end of 2025.

#### Hosted events to strategically engage members

In 2025, PMGMC aimed to host three member engagement events in its "Four Corners" series. It did so by hosting in-person events in Ocean City, Maryland; Tusla, Oklahoma; and Miami, Florida, with approximately 50 attendees at each event. As a result of the Maryland event, the hosting chapter sponsored two of its members to attend the Emerging Leaders Academy in Orlando.

#### **Collaborated on Pool and Spa Standard Development**

In 2025, PMGMC members played a key role in securing acceptance of the ICC/PHTA Swimming Pool Standards in the IAPMO Swimming Pool and Spa Code. This milestone promotes national code consistency and industry alignment. PMGMC also worked with the ICC code development committees to ensure proper correlation across plumbing, mechanical, and fuel gas disciplines in the ISPSC and related ICC/PHTA standards. This has enhanced the cohesiveness and usability of the model codes. PMGMC also worked with the Florida Building Commission to support adoption and harmonization at the state level.

#### PMGMC's 2026 Goals

**Connect and Develop Professional Relationships.** This goal includes encouraging at least three new organizations to utilize the Four Corners initiative and create a minimum of two new PMG chapters. PMGMC will also continue to support existing PMG chapters.

**Support the PMG I-Codes.** Maintain sustainability and adoptions throughout the continental US. This is an ongoing goal where PMG consistently experiences success through monitoring, reporting, and promoting the latest technology and standards.

**CodeNotes.** Publish the new CodeNotes from 2025. Produce a minimum of three new CodeNotes in 2026.





## Sustainability Membership Council

The purpose of the Sustainability Membership Council (SMC) is to advocate for concerns and issues related to sustainability that are of particular interest to builders, design professionals, industry, policy makers, and code officials, to assist ICC in increasing the participation of such individuals in the ICC Code development process, and to advise ICC on programs and policies, legislative matters, code adoption issues and such other matters as the Council deems appropriate.

SMC held eight meetings, with an average of 25 attendees per meeting. In 2025, SMC worked through four subcomittees: Membership Outreach, Education, Advocacy, and Certification. The subcommittees each have separate purposes and goals.

Some of SMC's major accomplishments in 2025 include:

#### **Engaged members through social media outreach**

SMC acheived engagement through "Coffee with SMC" and member outreach efforts coordinated with other MCs. During 2025, the "Coffee with the SMC" series consisted of 9 events with 122 logins, representing a high attendance of 23 as well as one hybrid event at the October Annual Conference. SMC also posted 30 new videos completed for Building Safety Month 2025 that were created in partnership with the other MCs. This resulted in 46 new followers throughout Building Safety Month.

## Hosted educational presentations during key ICC events

At the 2025 Annual Conference, there were numerous training opportunities centered around Energy Code and Sustainability. In addition, training has been provided as part of the "Coffee with the SMC" series.

## Raised awareness of sustainability-related certification opportunities

SMC promoted the Certified Sustainability Professional designation through social media platforms. The goal is to disseminate information about the certificate and promote this part of the profession. In addition, the Certification Subcommittee is preparing information to update criteria for achieving certification.

#### SMC's 2026 Goals

**Education Subcommittee.** Promote importance of energy code enforcement by hosting 12 "Coffee with the SMC" events, two training opportunities, and creating two introductory resources.

Advocacy Subcommittee. Continue to engage members through the Building Safety Month campaign by engaging with 10% more collaborators. Support the ELMC's Vote for Your Codes campaign. Respond to requests by the Code Council's Board of Directors to promote and support the energy codes. Finally, increase the number of impressions for SMC from over 17,000 to 20,000.

**Certification Subcommittee.** Increase awareness of available sustainability-related certifications and submit information to expand the availability of Sustainability Certification by pitching it in at least five avenues, creating one educational resource, and conducting one online survey.

**Member Outreach Subcommittee.** Increase SMC membership by 25%. Complete and promote the new member welcome package through the Steering Committee with buy-in from all MCs.








## Survey Overview


This survey was conducted April - July 2025 to let us know how we can engage members on the code development process. We received 500 survey responses to help guide our future efforts.





