What examination do I need to take?

When can I test?

Testing is immediately available upon purchase of the exam—24 hours a day, 7 days a week, 365 days a year.

How do I schedule/register for an exam?

The California self-certification examinations are administered through PRONTO.



What is **PRONTO**?

The International Code Council is proud to offer our proctored-remote online testing option (PRONTO). Through PRONTO, you can take your exam at your convenience on your home or office computer through a cloud-based testing system, offering secured online proctored exams. You will need a webcam and computer with working audio quality.

How often can I test?

In any six (6) month period, you may take an exam up to six (6) times, if necessary, to pass.

What if I have special needs?

What type of question format will be included in the examination?

Test questions are in multiple-choice format, with one answer on each question scored as correct. Due to the rigorous psychometric processes used by the Code Council in exam development, questions do not follow patterns (e.g., "the most common answer is 'B'").

Can't I just look up all of the answers in the books?

Because of the time constraints, you will not have time to look up all of the answers. For those answers you must look up, you must be VERY familiar with the references to avoid wasting time searching for information. First impressions are often the most accurate, but you may change your answers if time allows.

Should I guess if I don't know the answer to a question?

There is no guessing penalty, so it is to your advantage to answer every question. Remember to base your answers on the listed references for each exam, not solely on long-time field practices.

When will I receive my results?

Results for examinations taken electronically are available immediately after completion of the examination.

How do I make comments about an exam I took?
