## Call for Committee - ICC Performance Code Consensus Committee

The International Code Council is currently accepting applications for the following Committee:

ICC Performance Code Consensus Committee. As an ANSI accredited standards developing organization, the Code Council is redeveloping the ICCPC through the ICC Consensus Procedures. This will remain as a code but developed through this process. The purpose of the redevelopment is to better reflect the issues of today including climate change, rapid technological change, lack of housing and a need for resiliency. Additionally creating a single committee will allow the broad stakeholders to work more closely together. The redevelopment will be aiming to provide a more holistic approach to deal with the full lifecycle of buildings, structures, and facilities. A staff draft will be prepared for the committee to begin the development of the initial draft.

The scope of this code is intended to provide performance-based requirements for buildings and structures and includes provisions for structural strength, stability, sanitation, means of access and egress, light and ventilation, safety to life and protection of property from fire, sustainability, energy performance, indoor air quality, and mechanisms to facilitate community resilience and, in general, to secure life and property from other hazards affecting the built environment. This code includes provisions for the use and occupancy of buildings, structures, facilities and premises, their alteration, repair, maintenance, removal, demolition, and the installation and maintenance of amenities including, but not limited to, such services as the electrical, gas, mechanical, plumbing, energy conservation and building transportation systems; and for the storage, handling and use of explosive, flammable and combustible materials, hazardous materials and dangerous operations and processes. This code will address building performance in-use (outcomes) as well as at the design stage. Functional recovery, as a means to support community resilience, will be addressed.

The ICCPC is a unique regulatory tool that holistically addresses the built environment. There is a desire that those applying to this committee have an interest and if possible experience with performance-based analysis, design or regulatory systems. This committee encourages folks both within the United States and beyond to apply. Once appointed, this committee will convene to continue to reimagine the ICC PC through the ICC Consensus Procedures.
