## **Top News**

- The U.S. Department of Energy (DOE) has issued a determination that the updated model energy code for residential buildings, the 2024 International Energy Conservation Code<sup>®</sup> (IECC), will increase energy efficiency in residential buildings. DOE technical analysis, performed by Pacific Northwest National Laboratory (PNNL), estimates that buildings meeting the 2024 IECC would result in national site energy savings of 7.8 percent, source energy savings of 6.8 percent and energy cost savings of 6.6 percent. Supporting technical analysis, as well as previous model energy code determinations, are available here. PNNL also conducted an economic analysis finding national life-cycle savings of \$3,000 and a return on investment of 2.5 years.
