

ICC SMS Terms and Conditions

Effective Date: March 12, 2018

International Code Council, Inc. ("ICC," "we," "us," or "our") provides these SMS Terms and Conditions (the "SMS Terms"), which govern the provision and delivery of text messages by us or our text message service providers to you. ICC provides this text message service to: (1) provide you with information you requested from ICC and/or (2) inform you of ICC services or features that may be of interest to you.

E-SIGN Disclosure

By agreeing to receive text messages, you also consent to the use of an electronic record to document your agreement. You may withdraw your consent to the use of the electronic record by sending an email to <u>marketing@iccsafe.org</u> with "Revoke Electronic Consent" in the subject line. To view and retain a copy of this disclosure or any information regarding your enrollment in this program, you will need (i) a device (such as a computer or mobile phone) with a web browser and Internet access and (ii) either a printer or storage space on such device. For a free paper copy, or to update our records of your contact information, send an email to <u>marketing@iccsafe.org</u> with contact information and the address for delivery.

Signing Up For ICC Text Messages

ICC may offer different methods for you to sign up to receive text messages from ICC, including through the ICC website. By signing up to receive text messages, you agree to these SMS Terms, <u>ICC's Privacy</u> Policy, and other ICC terms available on ICC's Legal page governing use of our website.

By signing up to receive ICC text messages, you agree that ICC or its agents may use any automated or nonautomated technology to send you informational and promotional text messages. You understand that you are not required to receive ICC text messages as a condition of attending ICC meetings or otherwise using services or products made available by ICC.

Costs of Signing Up for ICC Text Messages

ICC does not charge you for its text message program. But message and data rates may apply, so depending on your plan with your wireless or other applicable provider, you may be charged by your carrier or other applicable provider.

Frequency of Text Messages

We may send you an initial message confirming that we have received your opt-in. After that, the specific amount of text messages may vary depending on how you use our services and the types of text messages you registered to receive. For example, if you sign up to receive text messages regarding ICC meetings, you may receive more frequent text messages during and before the meetings.

Opting Out of ICC Text Messages

If you no longer want to receive ICC text messages, you may text STOP to 77453. After doing so, we may send you confirmation of your opt-out via text message. If you have revoked consent and want to



re-enroll in our text message program, you can resume your enrollment by texting ICChearings to 77453. You may re-enroll via text message only.

No mobile information will be shared with any third parties or affiliates for marketing or promotional purposes.

We reserve the right to modify these SMS Terms, or any part thereof, or add or remove terms at any time, and such modifications, additions or deletions will be effective immediately upon posting. Your continued enrollment in ICC's text messaging program shall be deemed to constitute acceptance by you of such modifications, additions or deletions.
