Our lab facilities have expanded to better serve our customers, and we have joined forces with other industry-leading organizations to amplify our resources. The [Safe and Sustainable Cabinetry](#) program was launched.




| ICC-ES became a founding member of the [North American Accreditation Forum \(NAAF\)](#) established in June 2023 by accreditation bodies in North America.

In 2023, we launched a new code development process for the 2027 International Codes® and collaborated with international jurisdictions to create codes tailored to their communities. We also expanded our resources and standards to better meet industry needs. Here's a look at our achievements in 2023 as we continued to support the built environment with industry-leading building codes and standards.

- MOU signed between ICC, Saudi Building Code National Committee, and Gulf Standardization Organization to pave the way for the release of the Gulf Building Codes.
- Launched the new code development process.
- U.S. Department of Energy (DOE) published a new report "Enhancing Resilience in Buildings Through Energy Efficiency: Standardized Methodology and Resulting Analysis Demonstrating the Value of Codes and Above Code Measures to Hazard Resilience," outlining the resilience benefits of the 2021 International Energy Conservation Code® (IECC) in response to more frequent and intense extreme weather events attributed to climate change.




Standards and Guidelines



Released 2024 International Codes.

- Developed the first edition of **ICC 1210: Standard for Mechanical, Electrical, Plumbing Systems, Energy Efficiency and Water Conservation in Off-site Construction**.
- Published new **Guideline G6, Guideline on Advanced Panelization**, in response to the continuing needs of the off-site construction industry.
- Updated ICC 300: Standard on Bleachers, Folding and Telescopic Seating, and Grandstands.
- Updated ICC/NSSA 500: Standard for the Design and Construction of Storm Shelters.
- Began new development projects for standard ICC 1150: Standard for 3D Automated Construction Technology for 3D Concrete Walls and Guideline G7: Existing Building Inspection Guideline.
- Became Accredited by the **Standards Council of Canada (SCC)** as a standards developing organization (SDO) to develop National Standards of Canada and participate on



the SCC advisory committee for Canadian standards developing organizations (SDOAC).

| Existing Building Safety – A Guideline for Inspection was published to provide guidance to contractors, property owners, building managers, design professionals and code professionals regarding maintenance and milestone inspections on existing buildings.

Innovation and Off-site Construction

| Our tiny house initiative was launched in support of ICC's off-site construction initiative, including development of resources to support implementation. With the Tiny Home Industry Association, initiated development of ICC/THIA Standard 1215 on Tiny Houses used as Permanent Dwellings.

| The Code Council created an Ad Hoc Committee on Batteries and Energy Storage to explore how building safety is impacted by the manufacturing, storage, use and recycling of batteries and energy storage systems.

| National Labs study finds updating to the 2021 IECC can reduce deaths from extreme heat by as much as 80 percent.

2021 IECC

2021 IECC: A Code on a Mission

States and localities have set either greenhouse gas (GHG) reduction goals or established zero-energy building targets. The U.S. Administration has set zero-energy building goals of 2030 for new construction and 2050 for all buildings.

National, state and local governments cannot meet their GHG reduction goals without addressing buildings and thus having building energy codes that align with the goals.

The International Code Council is launching the Code on a Mission challenge to get over a third of the U.S. population covered by energy codes based on the 2021 IECC by the end of 2023.

The Infrastructure Investment and Jobs Act (IIJA) will make available an unprecedented \$225 million investment towards energy code implementation through the new Resilient and Efficient Codes Implementation (RECI) program. The Inflation Reduction Act (IRA) will make \$1 billion available for Building Code Technical Assistance. This includes \$330 million to adopt the latest building energy code, including the 2021 International Energy Conservation Code (IECC), and \$670 million to adopt a building energy code that meets or exceeds the zero-energy provisions in the 2021 IECC.
