I. WELCOME AND INTRODUCTIONS

Call to Order. Medard Kopczynski, Chair called the meeting to order.

David Torgerson and Nick Lauria have drafted a development outline document for Chapter 3 that includes the following items for discussion: purpose, definition of the problem, scan the environment and needs assessment.

Additionally, a table of document references has been created. This includes a list of current recommendations from the latest research regarding hazard mitigation strategies to increase structure survivability and the current model codes and standards.

C. Building Design Requirements: Chris Brunette, Chair Kathy Clay, Vice-Chair

Chris Brunette provided an update of the current status of the task group. Task group meetings have occurred on Jan. 13th and Jan. 27th the next meeting is scheduled for Feb. 10th.

The chapters under development have been placed in the group Google drive for review and comment. The suggestion function is to be used and terms and standards are to be highlighted within the document.

At the Jan. 27th meeting there was a presentation from Milad Shabanian on the IWUIC Ignition Resistant Classes and a review of the completed work on Section 502.
