#### A. Administrative Requirements:

#### Shamim Rashid-Sumar, Chair Steve Winistorfer, Vice-Chair

Shamim Rashid-Sumar provided an update of the task group progress. The group meets every 3 weeks on Mondays at 1pm Eastern time. The next meeting is on June 12th.

Shamim presented for discussion the latest task group draft of the Scope Section 101.1 that included feedback from Task Group 2. It was decided to remove the text of "and other residential structures not more than three stories above grade plane" from the draft.

Larry Novak, ICC requested that a comparison document that shows the changes between the previously committee approved scope from the committee meeting on November 1, 2022, and the new Task Group 1 developed scope section. Shamim stated that this document would be provided for the next meeting.

Shamim also reported that Task Group 1 has reviewed the ICC provided strategy document and suggested to add "area" to Figure 1 on Page 2.

#### B. Site and Area Requirements:

Anne Cope, Chair Marco Mack <u>Milad Shabanian</u>, Vice-Chair

Anne Cope provided an update of the task group progress. The group meets every 3 weeks on Tuesdays at 2pm Eastern time. The next meeting is on June 6th.

Anne also reported that Task Group 2 has started reviewing the ICC provided strategy document and suggested to add the "area outside" to Figure 1 on Page 2.

#### C. Building Design Requirements: Chris Brunette, Chair Kathy Clay, Vice-Chair

Chris Brunette provided an update of the task group progress. The group meets every 2 weeks on Fridays at 11am Mountain time. The next meeting is on June 2nd.

Chris reported that Task Group 3 has reviewed the ICC provided strategy document and provided the following recommendations:

- Multi-family residential structures will not be included in the 1<sup>st</sup> edition of the standard.
- The architectural design and shape of residential structures will not be included in the 1<sup>st</sup> edition of the standard.
- Attached accessory structures that are attached and in "close" proximity but not perpendicular to the main residential structure will be addressed.
- Detached accessory structures will be considered to be part of the hazard.

- **A. Next meeting** Keith Enstrom, ICC stated that future full committee meetings would be scheduled every four weeks on a reoccurring basis. The next meeting is scheduled for June 19th.
