

Residential Seismic Assessment and Retrofit Standard Consensus Committee

Feb 17th, 2022 at 2:00 PM to 5:00 PM CT MEETING #8 Minutes (for committee approval)

The 8th meeting of the ICC Residential Seismic Assessment and Retrofit Standard Consensus Committee (IS-RSARC) was convened on Feb 17th, 2021 to advance the ICC 1300 standard.

Date: Feb 17th, 2022 Venue: Virtual Mtg Online

1. Welcome / Opening Statements: Larry Novak, ICC / Chief Structural Engineer / Codes & Standards Development, called the three (3) hour-long meeting to order at 2:00 PM and welcomed all committee members, ICC staff and interested parties.

2. Identification of Representation / Conflict of Interest:

- a) ICC Council Policy 7 Committees: Section 5.1.10 Representation of Interests (attached)
- b) ICC Code of Ethics ICC advocates commitment to a standard of professional behavior that exemplifies the highest ideals and principles of ethical conduct which include integrity, honesty, and fairness. As part of this commitment, it is expected that participants shall act with courtesy, competence, and respect for others.
- 3. Roll Call: See attached attendance sheet. Mr. Novak called roll on the IS-RSARC committee voting members and noted that we had a quorum to conduct business.
- 4. Approve Minutes from previous meeting: Approved the minutes by vote of the committee with a modification of deleting #6-b-ii.

6. Task Groups Reports (fist name is task group organizer)

- a) Task Group Administrative (AD) Ch. 1, 2, 3, 8 and Existing App: Kelly Cobeen, Ronald Lynn, Larry Stevig, Roy Harthorn
 - i) Presented the work of the task group.
 - ii) The WG worked on solving the conflict between chapter 2 and chapter 3
 - iii) Recommendation to modify hillside dwelling definition. (straw pole results for the change 7 to 0)
 - iv) Incorporation of comments for Gary Ehrlich
 - v) The WG worked on Section 1.4.1 for retrofit scope and Table 1.7.1 regarding unit weight for stucco for 10 to 12psf. The group used the 12 to include the highest exterior wall finish.
 - vi) WG agreed that there is no italic other than the definitions according to ICC style.
 - vii) WG investigated foundation sill plate definition.
 - viii) Toe downs definition need to be changed to hold down per IRC. (straw pole results for the change 8 to 0)
 - ix) Chapter 3 included Garry's editorial suggestions and worked on section 3.1 to compile all minimum requirements in one location. The section also included prevision from the IRC, offering an option to use the adopted code and added exception
 - x) The WG looked into the verification of existing foundations and added fig 3.1-1.
 - xi) The WG also looked into the Commentary.
 - xii) The committee Agreed on using ASCE 7-16, and the rest is consistent with IBC and IRC 2021.
- b) Task Group Crawlspace Dwellings (CD) Ch. 4: Omar Amini, Howard Cook, Phil Line, Thor Matteson, Gary Ehrlich, Janiele Maffei
 i) Presented the work of the task group.
 - ii) Discussed WG goals.
 - iii) The WG submitted four documents.
 - iv) Section 4.4.7 existing foundation requirements, moved to chapter 3
 - v) The WG added clarification for anchors and hold-down requirements
 - vi) The WG is looking into the drawings and figures and ensuring they are consistent with chapter 5.
 - vii) For the plan set, the WG is working on removing any product-specific connectors and adding the details from the chapters.
 - viii) The WG provided two tables as samples, and they need feedback from the committee before completing the other tables.
 - ix) Committee polls:
 - x) The update to the table for one segment and eliminating the round up- (straw pole results for the change 4 VS 1)
 - xi) Use current code and ASCE 7-16 or updated codes ASCE7-21 (straw pole results 5 VS 0 (2 no preference) for Use current code and ASCE 7-16.
 - xii) Adding factor for two segments, 1.3 is ok. (straw pole results for the change 1-5)

 - iv) Figures vs. tables. The committee agreed on naming tables as tables in the standard.
- d) Task Group Hillside Dwellings (HD) Ch. 6: Mike Cochran, Dan Dolan, Thor Matteson, Howard Cook, Phil Line, Gary Ehrlich
 i) Discussed the work of the Task Group.
 - ii) The WG is working on updating the figures and incorporating feedback
 - iii) Added additional comments on fig 6.1.1a, and d.
 - iv) The WG worked on the commentary.
 - v) The WG is still working in figure 6.5. added a note on the primary anchor option is not the only way to do it.
- e) Task Group: Chimneys (CH) Ch. 7: Ron Lynn, Kevin McOsker, Roy Harthorn, Kelly Cobeen
 - i) Presented the work of the task group.
 - ii) Sent the updated plan set drawing to ICC publications
 - iii) Print them by 11 x 17, and the fonts need to be set up to be readable
 - iv) On page 18, 7.6.1, # 8 needs more clarification.
