## **International Code Council's Mark Johnson Appointed President of RESNET's Board of Directors**

The two organizations have collaborated to develop several new [RESNET American National Standards Institute \(ANSI\) standards](#), update existing RESNET/ICC standards, and create a new certification designation, the [International Energy Conservation Code \(IECC\)/Home Energy Rating System \(HERS\) Compliance Specialist](#).

“For years, RESNET and the Code Council have collaborated successfully on the development and publication of joint ANSI standards, helped educate code officials on the value of the HERS Index, and raised awareness on how to improve energy code compliance,” said Steve Baden, RESNET Executive Director. “Mark's previous experience as Vice President on the RESNET Board of Directors and years of

experience at the Code Council will help propel our organization forward and strengthen the collaboration between the Code Council and RESNET.”
