I HAVE BEEN WORKING IN THE CONSTRUCTION INDUSTRY SINCE 1986 AND I AM CURRENTLY BUILDING OFFICIAL FOR THE CITY OF ESTACADA, OREGON. I SERVE AS BOARD PRESIDENT AND CEO OF NORTHWEST CODE PROFESSIONALS. I WAS AN ADJUNCT INSTRUCTOR FOR CLATSOP COMMUNITY COLLEGE BUILDING CODES AND HISTORIC PRESERVATION/CAD PROGRAM FROM 2009-2016. IN 2020 I WAS APPOINTED TO THE STATE OF OREGON DCBS, BUILDING DEPARTMENT RULES ADVISORY COMMITTEE.
