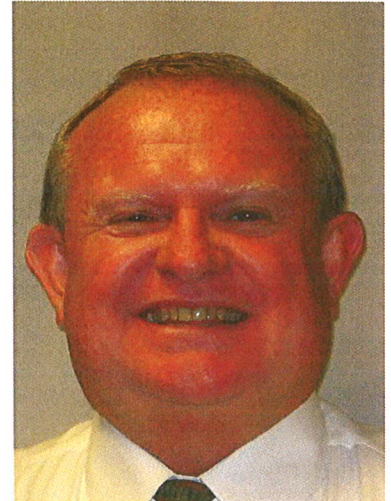

Building Official and Fire Marshal, 1993 to present

As the Building Official for Johnson County, Jerry directs the Building and Codes Division of the Planning Department, assuring the quality delivery of inspection, plan review, and preconstruction services. As the chief operating officer for the Division, he is responsible for the administration of standard operating services, policies, and enforcement, as well as staff development. He implements procedures for the enhancement of services and guides staff in the development of best practice manuals. Jerry oversees the Johnson County Contractor Licensing program and as Fire Marshal, supervises the County Fire Inspector, while coordinating the Division's work with that of three Fire Districts. Jerry acts as the Building Official for two extra-territorial, incorporated cities and works with a third in an advisory capacity. He conducts investigations, hearings, and public meetings, appearing regularly before public assemblies, governing bodies, as well as boards.
