My primary role is to direct and provide strategic management of the department, which performs over 100,000 inspections a year on over \$1 billion dollars' worth of construction annually. Specifically, working with the assistant director I develop and implement policy to provide effective building safety regulatory services, and manage a 5-million-dollar budget. My favorite part of the job is developing and maintaining effective relationships to facilitate a team approach to building code enforcement, department management, and the community development process and mission. A goal which I have been very successful at is to develop employees at all levels that can solve problems and make decisions. I participate in the code development process at the state level and ICC, and the legislative process at the Virginia General Assembly.

### **Accomplishments:**

- Developed a methodology and business case model to manage inspection division manpower and justify additional staffing needs as part of the budget process. The business case was successful in securing five staff positions over four fiscal years. The business case model has been referenced by the Budget Department and the Learning and Performance center as an example of how to build a proper business case.
- Developed five division chiefs into great leaders that operate the department so well we are considered a model department within the building inspection community and the construction industry.
- Provided key leadership working with the Crystal Lakes Apartments project, which has led to revitalization of Chesterfield's largest apartment complex.
- Led the Virginia Building Code Officials Association's lobbying efforts at the Virginia General Assembly since 2008 with almost a 100% success rate.
- In partnership with Human Resources, worked several significant personnel issues to successful conclusion.
- Implemented a revised career ladder program for the inspection staff and led implementation of a career ladder program for the permit technician staff.
