While "supplements" are not explicitly written into the ASC procedures, the key is that all of the consensus procedures are followed for approval of that portion of the standard.

The procedure for approval of supplements to the A117.1 standard has always been an option but has not been pursued until now. The need to provide the technical standard for this particular feature was deemed critical due to coordination requirements with the scoping standard.

Karl and Ken gave an overview of the Jan. 16 meeting regarding suggestions for revisions to the ICC A117.1 procedures.
