# E) Review of Proposals:

The following proposals were decided during the call. See the report for official committee reasons and final actions. Any items remaining on the agenda will roll to the next agenda —

Since 06-40 was tabled during the discussion from the last call, Ken had Gina Hilberry serve as chair to finish this change. Ken took over for the remainder of the meeting.

- 06-40 modification The proposal was divided for discussion. Chair (Gina Hilberry) decided changes to Section 607.2 were editorial; Part 1 607.3 (toe clearance) AM 18-7-5; Part 2 607.4 (control location) AM 5-22-2; D 25-0-2
- 06-59 modification The proposal was divided for discussion. Mod to delete change to 608.4.1 (control location) AM 23-1-1; mod new 608.2.1.3 (toe clearance) AM 9-19-2l; D 28-1-1; Mod for 608.2.1.2 and 608.2.1.2.1 (transfer clearance) AM 12-15-3; D entire proposal 28-1-2 Committee requested editorial or terminology task group to look at 'clear floor space' vs. 'clearance' for consistent use.
- 11-29 The proposal was divided for discussion. The proposed modification was revised to be only for bathtubs Section 1104.11.3.1.3.1 and 1104.11.3.2.3.1 AM 5-20-4; D 25-1-3
- 06-38 modification AM with 2<sup>nd</sup> replacement 22-1-3
- 06-13- modification AS;
  - This proposal was split and tabled during the 8-25-2022 meeting. The proponent submitted a replacement proposal that was substantially different from the original proposal. Therefore, the motions and actions taken on 8-25-2022 are void and the discussion will start over.
  - o The proponent asked for the proposal to be divided for discussion:
  - o Part 1 Definition for 'stanchion' AM 5-21-2; D 23-3-3
  - o Part 2 Section 603 and 604; Ken decided that the revision of Section 604.10 to 612 is out of order. This revision is not included. AM 11-13-1; D 25-4-2
  - o Part 3 Section 609 –
  - o Ken decided that 609.2.2 change from 4.8 to 6.3 is only applicable to stanchions.

- o Marsha Mazz requested Section 609.9 be heard separately
- o The item was tabled due to the discussion extending 45 minutes past the scheduled meeting time. Tabled 12-9-0
- o Part 4 Section 612(new)
