**D. Review of Proposals:**

Scoping -

- Gina, Gene and Kim gave general report on the efforts of the scoping committee.
- The Scoping Appendix is being reordered to group items in a cleaner manner, remove redundancy, and address some of the committee questions/concerns.
- Gina then proceeded to show examples of the revisions in the document.

- Koni suggested using distinct characters before and after every strike out and underline. Suggestions for easy removal later were \ and [. Kim to check with Laurie Rich to see if an option has been decided on for all ICC documents.
- Gina explained the purpose of the Appendix – allow for governments to adopt the standard with the Appendix as an alternative to compliance with the ADA.
- This includes provision from IBC, ADA and HUD requirements.
- Definitions in Section 107 are not repeated in the Appendix
- Gina described the general organization – A201 Administrative, A202 Exceptions and general requirements, A203 special uses, A204 existing buildings.
- Gina and then Gene went through each item for committee input and questions. See the file for notes to the scoping work group.
