

PUBLIC MEETING Magnesium Oxide Board Standard Consensus Committee (IS-MGOB) (Preliminary Minutes)

The eighth public meeting of the ICC Magnesium Oxide Board Standard Consensus Committee (IS-MGOB) was convened on March 28, 2025, to review the public comments of the initial draft of the standard. The teleconference meeting was conducted through Teams.

1. Meeting Opening

a. Opening remarks, objective of the meeting, and housekeeping:

Committee Chair, Jarrett Davis called the meeting to order at 10:05 am EDT and welcomed all committee members, interested parties and ICC staff.
