Erfigen Brings Green Code Experience to Her Role as ICC Sustainability Membership Council Chair

*New Council will serve needs of green and energy code enforcement officials
and other industry professionals*

The chair of the [International Code Council](http://www.iccsafe.org)'s Sustainability Membership Council Governing Committee is a knowledgeable code enforcement official and an ICC-certified CALGreen Plan Examiner and Inspector.

“New green codes and renewed interest in energy conservation codes are opening up new career paths and creating on-the-job challenges for code enforcement officials,” [Transtech Engineers](http://www.transtech.com) Building and Safety Supervisor Ayla Erfigen said. “I’m from California, and we already have a green code that we are enforcing. The Sustainability Council will be able to discuss green- and energy-related matters and offer peer group help and support.”

The ICC Board approved five discipline-specific [Membership Councils](#): Sustainability, including energy; Building Officials; Plumbing, Mechanical and Fuel Gas; Global Members; and Fire Service. Each Council will advocate for concerns and issues that are of particular importance to its discipline.

Through Governing Committees, the Membership Councils will:

- Build and improve relationships with stakeholders who have an interest in safe and sustainable construction;

- Provide opportunities to enhance the understanding, acceptance and adoption of ICC codes related to the Sustainable Membership Council;
- Make recommendations for ICC training, certification and other programs related to sustainability;
- Keep ICC stakeholders informed and engaged in the association's activities; and
- Act as an advocate for professional or technical interest areas and receive feedback.
