A PROCLAMATION IN SUPPORT OF MAY 2025 AS BUILDING SAFETY MONTH

WHEREAS, Nye County is committed to recognizing that our growth and strength depends on the safety and essential role our homes, buildings and infrastructure play, both in everyday life and when disasters strike, and;
